

PRIVACY POLICY

Register to e-news

In order for you to register to e-news, the company TURIZEM BLED, zavod za pospeševanje turizma Bled, collects the following information: your e-mail, first name and surname. The data controller, TURIZEM BLED, zavod za pospeševanje turizma Bled, collects your personal data only if it was voluntarily provided by you upon registering to e-news.

By entering your e-mail address you are registering to e-news with which TURIZEM BLED, zavod za pospeševanje turizma Bled, will notify you about novelties in its offers, discounts, promotions and special benefits and current prize games.

After entering your e-mail address in order to receive e-news, you will receive a confirmation e-mail – which you need to confirm to activate your consent, after which you will be registered to the e-news of TURIZEM BLED, zavod za pospeševanje turizma Bled, until revocation.

Your personal data, which is required to login to the e-news, will be used only for purposes for which you have given your consent. In no case will TURIZEM BLED, zavod za pospeševanje turizma Bled, sell, lend or in any other way forward your personal data to unauthorised third parties without your consent.

Revoking the consent

You may revoke your consent for the use and management of your personal data at any time and in the same manner as you have given it. In order to revoke your consent, simply re-enter your login e-mail into the registration form on the website and you will receive a confirmation e-mail. By confirming it the consent revocation will be activated.

Logout

You may at any time request in writing a permanent or temporary prohibition of use of your personal data for purposes of direct marketing from the personal data controller to the e-mail address info@visitbled.si or by clicking LOGOUT in e-news.

User's rights

Users may at any time select and send a relevant request for access to personal data, collected and processed by the personal data controller, via the contact form below in order to correct, delete personal data and restrict its processing in relation to each individual to whom personal data refers, and to object to the processing of personal data or to its transferability.

In case of violation of their rights during the collection, processing and storage of personal data, web users may at any time file a complaint to the IT representative and shall also be entitled to legal remedies, indemnification and liability in case of failure to take action by the supervisory body.

Data protection

The data controller, TURIZEM BLED, zavod za pospeševanje turizma Bled, respects your right to privacy and strives toward ensuring the highest level of personal data protection. For this reason we are committed to operate in accordance with laws and regulations defining personal data protection, particularly in accordance with the applicable Personal Data Protection Act, Personal Data Protection Act and General Data Protection Regulation of the EU.

TURIZEM BLED, zavod za pospeševanje turizma Bled, will send e-news through the GDPR manager web application, which ensures full anonymisation of personal data of e-news recipients and enables, in accordance with the minimisation principle, access to personal data exclusively to authorised persons and only on the basis of received requests for correction, access, restriction, objection, transfer or deletion of personal data.

The GDPR manager web application ensures complete traceability of authorised users of the application (user name and password protected access to the application) and automatically records access of authorised users to the application and their activities within it.

TURIZEM BLED, zavod za pospeševanje turizma Bled, will protect personal data with due care and diligence and prevent its possible misuse. Your personal data will be used only for purposes for which you have given your consent, and user name and password protected access to it will be granted only to authorised persons of the personal data controller, who are bound to manage personal data with due care and diligence in accordance with the applicable EU legislation.
